Background: Cobalt is an increasingly important commodity that is essential for rechargeable batteries, for example in mobile phones and electric vehicles. About half of the world's reserves of cobalt are in the Congo (DRC). The cobalt is used by large electronics, car and battery manufacturers many institutional investors invest in, usually through many intermediaries (there could be as many as eight or more links in the supply chain: miners, traders, smelters etc.).

In the beginning of 2016, Amnesty International published a report about child labour in artisanal cobalt mining in the DRC. In response, several institutional investors started making enquiries about the use of children in cobalt mining in the DRC at a number of large companies that most institutional investors are invested in. As the response was poor, a coalition of 23 large investors, including MN and Triodos Asset Management, was formed at the initiative of the Dutch pension fund asset manager APG to tackle this problem.

The investors' coalition approached thirteen companies to ask what they are doing to prevent children being used in mining their cobalt. We also asked other stakeholders to take action by underlining the importance of this for large investors. The Responsible Business Alliance (formerly the EICC) launched the Responsible Raw Materials Initiative (RRMI) at the UN Forum on Business and Human Rights in 2016. This new initiative has since joined with the Responsible Minerals Initiative (formerly CFSI) and includes cobalt as one of its focus areas. Also the Chinese Chamber of Commerce for Metals, Minerals & Chemicals (CCCMC) launched a 'Responsible Cobalt Initiative' (RCI).

This year a number of promising initiatives got off the ground. A number of companies released detailed reports on the sourcing of cobalt. Others play active roles in the RRMI or RCI. In the panel each of the speakers will highlight progress and challenges.

Arthur van Mansvelt
