#### [Tunisia: The quest for dignity, social justice and human rights](#)


In their mission report to Tunisia (26 January – 2 February 2011), OHCHR's high-level team highlighted the importance of the indivisibility and interdependence of human rights. The team identified "the denial of dignity" as the underlying cause of the uprising and the aspiration of the people for a responsible and accountable government that delivers on all human rights and social justice. The report discusses how the concentration of economic and political power in the hands of a group of privileged individuals resulted in striking economic and social disparities and denial of basic economic and social rights for very large sectors of the population.

### OHCHR's new tool to address forced evictions

The "Forced Evictions Assessment Questionnaire" is intended to serve as a guidance tool for addressing situations of forced evictions by: a) contextualizing events; b) assessing the existence and the type of human rights violations that are foreseen or on-going; c) offering practical advice to all parties; and d) helping to monitor and report on the situation.

### First session on human rights of older persons

The Open-ended Working Group was created in December 2010 (GA res. 65/182) to focus on strengthening the protection of the human rights of older persons. Its first session in New York (18-21 April) includes panels discussing the international and regional framework and existing mechanisms, as well as identifying gaps. Panelists include treaty body experts, members of various regional human rights systems, UN agencies, National Human Rights Institutions and NGOs.

## ACTIVITIES IN THE FIELD

### OHCHR-Nepal: transferring ESCR monitoring skills in remote areas

On 9 and 10 March 2011, OHCHR-Nepal conducted training on monitoring of economic, social and cultural rights (ESCR) in collaboration with the Human Rights Network, a coalition of human rights NGOs. Participants included 35 human rights defenders and government officials in Udayapur district, Eastern region of Nepal. The training produced an Action Plan to make the district “human rights friendly”, including goals related to measuring the enjoyment of ESCR in 2011 and beyond. The activity is part of OHCHR-Nepal’s efforts to strengthen the capacity of local stakeholders in remote areas of Nepal, where the enjoyment of ESCR is severely hampered.




## **Regional Office for South America: Observatory on the right to food**

Through its collaboration with FAO, OHCHR's Regional Office for South America supported and contributed to the first meeting of the *Observatorio del Derecho a la Alimentación*, a network of academic institutions working on the right to food. The meeting held in Bogotá, Colombia on 17 and 18 February 2011 gathered representatives from approximately 20 Latin-American universities and elected its technical secretariat. The work of the Observatorio will include regular publication of documents, financial support to research on the realization of the right to food by members and the creation of a virtual library. The Observatorio also requested OHCHR technical support in its institutional-building activities.

## **Mexico: “Public Policies and Budgets from a Human Rights Perspective”**

On 28 February 2011, OHCHR Mexico and other key Mexican partners published a handbook, primarily for public servants. It aims to provide technical knowledge and tools to incorporate the human rights perspective in the design, implementation, and evaluation of public policies. The handbook reflects the experiences and best practices gathered all along the process of formulation, discussion, approval, operation and evaluation of public budgets in Mexico City. The handbook provides clear indications on how and why human rights and international obligations of the State should be the main framework for designing and implementing public policies and budgets.

## **Central Africa Regional Office: Promoting and protecting the right to health in Cameroon**

On 24 February 2011, OHCHR Central Africa Regional Office/UN Centre for Human Rights and Democracy in Central Africa organized a forum in Yaoundé to raise awareness and advocate for the respect of the right to health in Cameroon. The main focus was on availability, accessibility, acceptability and quality of health services. A number of issues were raised during the discussions, including the lack of ethical behaviour from the medical personnel, impunity and the fact that healthcare services are widely perceived as a favour rather than a right for the population.

## **West Africa Regional Office: Legal protection of ESCRs and women and ESCRs**

From 21 to 23 February 2011, the OHCHR West Africa Regional Office (WARO) and the Ministry for the Promotion of Human Rights of Burkina Faso organized a regional training on the justiciability of ESCRs. The training took place in Ouagadougou with 30 magistrates and lawyers from six countries (Benin, Burkina Faso, Mali, Niger, Senegal and Togo). Participants adopted a final declaration, appointed a country focal point and agreed on specific actions as a follow-up to this event. WARO continued its advocacy for the ratification of the Optional Protocol to the ICESCR through workshops (30 and 31 March in Dakar, Senegal and during the World Social Forum in Dakar from 6 to 11 February 2011 and in

Cape Verde); support in the form of promotional material, radio messages (Cape Verde and Burkina Faso). The Office also organized an awareness-raising forum for women from civil society organizations on ESCR (28 February 2011, Dakar, Senegal).

### **Regional Office for Southern Africa celebrates World Water Day**

From 20 to 22 March 2011, OHCHR Regional Office for Southern Africa (ROSA) participated in a seminar on the right to water and sanitation, as part of the celebrations of World Water Day taking place in Cape Town. ROSA presentation focused on achievements and challenges at the international level in the protection of the right to water. It also used this opportunity to advocate for the ICESCR's ratification in the sub-region and for the issuance of open-ended invitations to special procedures.

### **Guatemala: supporting civil society and national institutions ESCR initiatives**

OHCHR-Guatemala supported several events in response to requests from civil society and national human rights institutions. On 23 February 2011, the Office contributed to the workshop for Government institutions on the third periodic report to the Committee on Economic, Social and Cultural Rights, organized by the *Comisión Presidencial Coordinadora de la Política del Ejecutivo en Materia de Derechos Humanos* (COPREDEH). From 8 to 10 March 2011, the Office also contributed to a three-day workshop on the justiciability of ESCR in Guatemala City conducted by international and national NGOs. The workshop aimed to build capacities of national and local NGOs regarding the justiciability of ESCR.

### [Special Rapporteur on situation of human rights in Myanmar addresses ESCR and the right to education](#)

The mandate of the Special Rapporteur on situation of human rights in Myanmar has usually focused on civil and political rights, humanitarian crisis and armed conflict. Acknowledging the dire situation of ESCR, the latest report of the Special Rapporteur to the Human Rights Council (A/HRC/16/5) focused on ESCR and more specifically on the right to education. While State authorities have still not accepted an official visit since February 2010, the Special Rapporteur hopes that discussion on this important area might help his dialogue with the Government.

### [Concerns about human rights defenders in India](#)

At the end of her official visit to India (10 to 21 January 2011), Margaret Sekaggya, Special Rapporteur on the situation of human rights defenders, expressed a number of concerns in relation to defenders in the country, in particular those denouncing development projects that threaten or destroy the land, natural resources and livelihood of communities; defenders working for the rights of marginalized people including those of minorities such as Dalits or sexual minorities, and women human rights defenders. She also pointed out the trend to target activists working on the Right To Information (RTI) Act, who may be ordinary citizens, exposing human rights violations and poor governance, including corruption of officials.

### [CEDAW: Women's housing, land and property rights](#)

During its review of State reports at its 48<sup>th</sup> session, the Committee on the Elimination of Discrimination against Women (CEDAW) made a number of recommendations on women's

rights to housing, land and property, including on forced eviction and house demolitions (Israel); the concept of “head of household” in administrative practice and the need for recognition of joint or co-ownership of land (Sri Lanka); and failures of slum-upgrading programmes to systematically address the needs of poor urban women (Kenya).

### **Expert meeting on the impact of recovery measures on the human rights of those living in extreme poverty**

From 27 to 28 January 2011, the Independent Expert on human rights and extreme poverty, Ms. Magdalena Sepúlveda Carmona, convened in Geneva an expert meeting on the “Impact of recovery measures on the human rights of those living in extreme poverty”, with the support of OHCHR, UNICEF and the Norwegian Centre for Human Rights. The purpose of the meeting was to create a forum to discuss, provide input to the Independent Expert's forthcoming report that will outline parameters for a human rights-based approach to recovery from the global economic and financial crises, with particular focus on the most vulnerable and marginalized groups (A/HRC/17/34).

### **Ending Homelessness: A Handbook for Policy Makers**

This handbook, developed by the European Federation of National Organisations Working with the Homeless (FEANTSA), aims at policy-makers and others seeking to tackle homelessness in Europe. It sets out a set of five goals for strategies to end homelessness, namely: (1) no one sleeping rough; (2) no one living in emergency accommodation for longer than is an “emergency”; (3) no one living in transitional accommodation longer than is required for successful move-on; (4) no one leaving an institution without housing options; and (5) no young people becoming homeless as a result of the transition to independent living.

## CASES, LEGISLATION & POLICIES

### Health care renunciation for economic reasons in Switzerland

A recent study indicates that in Geneva, Switzerland, 14.5% of the population (aged 35-74 years) renounced health care for economical reasons. 74% of the renunciations concerns dental care, 37% physician consultation, 26% health devices, 13% medication, and 5% surgery. 30% of the lowest income group renounced health care for economical reasons. Persons with the lowest income (<3000 CHF/month) renounced health care 9 times more frequently than those with the highest income (=13 000 CHF). The findings also highlight the fact that persons with lower income presented greater risk factors and renounced more frequently to consult health care services.

### World Bank Inspection Panel on eviction, land titling in Cambodia

Subsequent to a complaint launched by civil society organizations, the World Bank Inspection Panel found that the Bank's operational policies failed to properly design and supervise the Cambodia Land Management and Administration Project (LMAP). These failures contributed to the forced eviction of some 4,250 families living around Phnom Penh's Boeung Kak Lake. Residents were reportedly denied the right to register their land ownership shortly before the Government leased the area to a private developer and began pressuring families to leave the area. The World Bank Board of Executive Directors recently met to decide what action should be taken in light of the findings of the Inspection Panel.
