1. QUALIFICATIONS (200 words)

Relevant educational qualifications or equivalent professional experience in the field of human rights; good communication skills (i.e. orally and in writing) in one of the six official languages of the United Nations (i.e. Arabic, Chinese, English, French, Russian, Spanish.)

The candidate is currently serving as Chair of the Expert Mechanism with great recognition from her peers. She has engaged in activities for the negotiation and implementation of EMRIP's extended mandate, particularly in organizing its methods of work and improving the coordination with the other UN mechanism and treaty bodies, aiming to fulfill the expectations expressed by States, Indigenous Peoples and UN bodies towards the Mechanism.

Ms. Yamada has a bachelor degree in Law from Brazil, her home. She acquired her master and doctoral degrees in the field of human rights and indigenous peoples at well-known University programs in Sweden and in the United States. In addition to Portuguese as her mother tongue, she holds good communication skills in English and Spanish, and can understand basic French/creole, being able to hold intercultural dialogues with indigenous peoples from different regions and cultures.

Ms. Yamada has worked with indigenous affairs in the government of Brazil, as well as with national and international NGOs and local indigenous communities/organizations for the past thirteen years. She has developed significant technical work in the field of free prior and informed consent and consultation, indigenous peoples right to lands, indigenous peoples in volunteer isolation, and social policies for indigenous peoples. Most recently, she has worked on issues related to indigenous children rights and indigenous migration, and coordinated a reference research work of the International Organization for Migration (IOM) in Brazil.

The candidate is recognized among Brazilian government officials, human rights NGOs, scholars and, above all, among indigenous leaders from Brazil, from other Latin American countries as well as from Belize in the Caribbean region, due to her long standing work in the field of international human rights law and indigenous people's rights. For the past years, she has promoted the work of EMRIP as well as the Universal Periodic Review as important mechanisms for dialogue among States, NGOs and indigenous peoples.

Ms. Yamada attended the Indigenous Peoples Law and Policy Program at the University of Arizona (2006-2008), and has worked for fifteen years with cases for indigenous peoples rights in the UN and Interamerican Human Rights Systems. She received a doctor degree, under the academic supervision of Professor James Anaya, former UN Special Rapporteur on the Rights of Indigenous Peoples. In 2016, she assisted on the visit of the current UNSR, Victoria Tauli-Corpuz, to Brazil and became an EMRIP member for Latin America and Caribbean region. At EMRIP, among other things, she has led the country engagement requested by the government of Mexico City to implement the constitutional provisions and the UN Declaration on the Rights of Indigenous Peoples.

3. ESTABLISHED COMPETENCE (200 words)

In addition to her academic background, the candidate has substantial practical experience in the field of indigenous peoples's rights. Since 2009, she worked on legal cases at the national and international levels, and with public policies related to land rights. In 2015, she was appointed by a coalition of NGO's to serve as National Rapporteur for Human Rights and Indigenous Peoples and ,together with the National Human Rights Council, presented a comprehensive report on the situation of indigenous peoples in the southern region of Brazil and another on the relationship of economic policies and the human rights for indigenous peoples. Lately she has dedicated her attention to indigenous peoples' elaboration of their own protocols for consultation.

The candidate has worked with capacity building on human rights for different actors and has supported the enhanced participation of indigenous organizations in national, regional and international forums. Through her experience she has also been able to better understand the difficulties that States face to improve its laws and policies for indigenous peoples. As Chair of EMRIP, she has promoted the importance of a closer relationship of EMRIP with the different treaty bodies and human rights mechanisms and she has made efforts to ensure that the work of the Mechanism is useful for States and indigenous peoples.

Dear Sir or Madam,

I am pleased to apply for an extension to my mandate as an EMRIP member from Latin America and Caribbean Region. The past 3 years have been very challenging and inspiring to me and it is an honor to be serving as the Chair of the Mechanism in this stage of implementation of our new mandate.

We have worked as a team and achieved significant progress, particularly in relation to making our studies more relevant and exploring the possibilities of our country level activities to become useful for all parties. Nonetheless, much still need to be done and I believe I can continue to contribute, particularly in terms of establishing our methods of work in a practical manner and in great dialogue with States and Indigenous Peoples.

As an expert without indigenous background, I remain fully committed to disseminate information and to encourage the participation of indigenous peoples at UN discussions and mechanisms. My understanding is that still only few individuals fully understand and make use of the UN human rights' system in a continued and comprehensive manner. Therefore, I feel motivated to continue to work to further disseminate the work of EMRIP, particularly in LAC countries likewise Brazil and to encourage more indigenous peoples and organizations, NHRIs and Universities to engage in the construction of solutions and dialogues for the implementation of the UN Declaration on the Rights of Indigenous Peoples.

Other relevant global agreements related to human rights and indigenous peoples such as the Sustainable Development Goals, the Climate Change Agreements, the Global Compact on Migration and so on also motivate me to apply for an extended mandate. I believe that the years to come are a crucial time for our future and for the future of the planet and with regard to the long standing human rights. Therefore, it will be very relevant to continue to strengthen the UN System, bringing it closer to the reality of the peoples and the societies.

I consider myself very fortunate to have had the chance for the past 15 years and to continue to learn and work with peoples that live in and together with nature, that have so much to teach us on how to build peace and trust in societies. I have also assisted the 2 visits of UN Special Rapporteurs on the rights of indigenous peoples to Brazil, which allowed me to gain other perspectives on the challenges to implement international human rights standards and obligations. Working for the Brazilian Federal Government (FUNAI) with indigenous land's demarcation was an intensive training and opened my eyes to the difficulties the State itself has to implement participative policies that relate environment, human rights, and development when structural racism still persist in the institutions.

As a UN Independent Expert at the Expert Mechanism on the Rights of Indigenous Peoples, I have been able to put together all those lessons and concerns and have made all possible efforts to transform them into constructive responses, if not solutions to the similar problems indigenous peoples face around
