- The application process has been split into 2 parts, the first part is a Web-based survey and the second part is an application form in word which can be downloaded, completed and returned by email. Both parts and all sections of the application form should be filled in for the application to be processed.

The **first part**, i.e. the [Web-based survey](#) is used to collect information for statistical purposes such as personal data (i.e. name, gender, nationality), contact details, mandate/s applying for and nominating entity. **The web-based survey should only be completed once**, i.e. multiple selection allowed to indicate if the candidate is applying for more than one mandates.

This is the **second part, i.e.** of the application form in Word which can be downloaded, completed and saved in word format and then submitted as an attachment by email. Information provided in this form, includes a motivation letter of maximum 600 words, will be used as received to prepare the public list of candidates who applied for each vacancy and will be made available to concerned parties, including through the OHCHR Internet.

If the candidate is applying for more than one mandates, an application form needs to be completed and sent for each mandate.

- A maximum of 3 reference letters can be attached, in pdf format, to the application sent by email. No additional document is required.
- **Application Deadline: 31 OCTOBER 2013 (midnight, GMT).**
- Shortlisted candidates will be interviewed at a later stage.

I am a human rights defender with twenty years of combined academic and practical experience. I am motivated to serve as UN Special Rapporteur on the situation of human rights defenders because I wish to assist States in their efforts to strengthen the universal rights protection afforded to human rights defenders. More specifically, I seek to support the UN Human Rights Council in identifying practical ways of enhancing respect for the Declaration on the Right and Responsibility of Individuals, Groups and Organs of Society to Promote and Protect Universally Recognized Human Rights and Fundamental Freedoms and relevant provisions of international human rights law treaties. If appointed, I would promote respect for the full range of rights - social, political, cultural, civil and economic – by States and other relevant actors.

My global experience working with defenders, combined with my outstanding field and academic research skills, mean that I am ideally placed to build upon the work and vision of previous mandate holders. I have the ability to provide the UN Human Rights Council with accurate and impartial information on existing and emerging challenges faced by defenders working on a range of human rights issues in diverse geographical regions. I have the desire and expert knowledge to analyze the the obstacles faced by specific groups of defenders, including those working on gender, non-nationals, land rights, environmental protection, ethnic and religious minorities, children, political opposition groups, the media, people living in poverty and disadvantaged socio-economic groups. I have spent many years engaged in human rights research, capacity building and training in challenging conflict and post-conflict situations. If appointed, I would seek practical ways to enhance the protection of defenders working in precarious conflict situations. I am committed to ensuring that defenders working on the full range of human rights are provided with a 'contextual space' within which they can carry out their work effectively.

Furthermore, my skills mean that I am able to facilitate the formulation of practical responses to the range of challenges faced by defenders. My experience of training and working with Governments, the armed forces, law enforcement officials, members of the judiciary and legal community, international and regional inter-governmental organizations and civil society means that I know how to communicate in a respectful and appropriate manner with all key stakeholders. I am, therefore, ideally placed to respond to urgent communications, formulate legal and policy based recommendations and implementation strategies in partnership with relevant stakeholders.
