

Ordinary men and women who act for the respect of human rights, for instance

freedom of expression, the rights of women, of indigenous peoples or gay,

lesbian, transgender and intersex people. They can act alone or in organisations.

The Declaration is based on, consolidates and reflects binding international law relevant to the promotion, protection and defence of human rights

TO SEEK, OBTAIN, RECEIVE AND HOLD INFORMATION RELATING TO **HUMAN RIGHTS**



TO SUBMIT TO THE AUTHORITIES CRITICISM AND PROPOSALS FOR IMPROVING THEIR FUNCTIONING AND TO ALERT THEM ON ANY THREAT ON THE **REALIZATION OF** HUMAN RIGHTS











TO THE LAWFUL EXERCISE OF THE OCCUPATION OR PROFESSION OF HUMAN RIGHTS **DEFENDER**











THE DUTIES OF STATES

TO PROTECT, PROMOTE AND **IMPLEMENT ALL HUMAN RIGHTS**



TO ENSURE THAT ALL PERSONS UNDER ITS JURISDICTION ARE ABLE TO ENJOY ALL HUMAN **RIGHTS AND FUNDAMENTAL FREEDOMS**

TO ADOPT SUCH LEGISLATIVE, ADMINISTRATIVE AND OTHER STEPS TO ENSURE EFFECTIVE **IMPLEMENTATION OF RIGHTS AND FREEDOMS**



TO CONDUCT PROMPT AND **IMPARTIAL INVESTIGATIONS OF** ALLEGED VIOLATIONS OF HUMAN

TO PROMOTE PUBLIC ECONOMIC, SOCIAL AND CULTURAL



TO ENSURE AND SUPPORT THE INDEPENDENT NATIONAL HUMAN



TO PROMOTE AND FACILITATE HE TEACHING OF HUMAN RIGHTS AT ALL LEVELS OF FORMAL **EDUCATION AND PROFESSIONAL** TRAINING

TO TAKE ALL NECESSARY MEASURES
