## Table Indicating Where Elements of the 3<sup>rd</sup> Revised Draft May be Found in the Updated Draft LBI

In July 2023, the Chair-Rapporteur shared an <u>updated draft legally binding instrument</u>, along with a <u>version in track changes</u>. In accordance with paragraph 25 (g) of <u>A/HRC/52/41</u>, the Chair-Rapporteur updated the draft instrument taking into consideration:

- the concrete textual proposals and comments submitted by States during the eighth session on the 3<sup>rd</sup> Revised Draft, as well as on the Suggested Chair Proposals, and
- the outcomes of intersessional consultations as reported by the friends of the Chair (such consultations considered written inputs received in response to a note verbale of March 2023).

The updated draft legally binding instrument consolidates in a single text a proposed consensus on the various positions and proposals raised since the beginning of the openended intergovernmental working group. The draft streamlines the text in various ways, such that certain elements found in the 3<sup>rd</sup> Revised Draft are sometimes captured in different provisions. The table below indicates where elements of the 3<sup>rd</sup> Revised Draft may be found in the updated draft legally binding instrument. Note, the table below does not cover new elements introduced in the updated draft.
